## Interpretation:

Molecular genetic analysis was performed for a specific mutation reported to be associated with Exercise-Induced Collapse in dogs. We identified two normal copies of the DNA sequences in the *DNM1* gene tested. Thus, this dog is not at an increased risk for Exercise-Induced Collapse.

#### Recommendations:

No mutations were identified. Thus, this dog is not at an increased risk for the disease caused by or associated with the mutation tested. Because this dog is "clear" of this mutation, this dog will only pass the normal gene on to its offspring.
